Brush Chipping Service Changing to 2 Times a Year

After much discussion, the brush chipping service has been adjusted

to twice a year (versus previous monthly service). In 2024, the dates are May 14 and October 8. The Town Board discussed the strain on our Town Crew with abuse and overall increase in demand. It was noted that the excessive hours spent chipping (some months over 25% of the crew's time) took away from performing other Town services. A survey was conducted that showed support for the 2 times a year schedule.

If there are additional chipping needs, residents may contact a chipping service or haul their brush to the County Landfill at 3240 Berlin Drive (for a small fee).

With the decrease in dates, the established rules are still in effect to protect our workers and to control misuse of this taxpayer service. These rules include a limit to the amount of brush (no more than 3 feet tall and no wider than 15 feet along the curb), a requirement that cut ends face the road (messy piles take more time and can prove dangerous to our crew) and a request to call the Town office at 608-526-3354 to be placed on the pick-up list (no later than 1 pm the day before the service; leave a message 24/7).

This is a reminder that the Town is not in the <u>business</u> of chipping brush. We offer the <u>service</u> as a courtesy to assist with light pruning and trimming. Our service is NOT for tree removal or clearing building sites. **There will be NO EXCEPTIONS to the rules as listed above!** We thank you for your cooperation.

2024 brush chipping service will be offered on Tuesday, May 14, 2024
Tuesday, October 8, 2024

Additional dates may be added due to large storm events.



Compost Site Access

In 2023, the compost site was gated; now only Town residents are allowed use of the site. This has cut down on abuse by non-residents and, with the camera system and fob ID, has helped to identify any residents dumping illegal material at the site. Starting in 2024, the vendor switched from a flat fee for disposal (\$6,500 in 2023) to a per ton fee (estimated to cost between \$12,000 to \$18,000/year), thus the need to ensure the Holland taxpayers are not subsidizing non-town yard waste.

As with any new technology, we had a few hiccups (a lightning strike in July caused some angst). In spite of the disruptions in gate functions, the Town did notice a downturn in compost as a result of this new system.

The compost site is used for grass clippings, leaves or other compostable vegetation. This site is located to the west of the Town hall. No paper/plastic bags or branches/brush are allowed. Garbage cans are provided for you to dispose of bags. *PLEASE* back up as much as possible to the pile before unloading. Dropping it in the middle of the driveway makes it harder for everyone!

Residents who wish to use the compost drop-off site will be required to obtain an access key-fob from the Town Clerk. The 2024 yearly cost for the service will be \$20 (with a one-time \$6 key-fob charge). If you obtained a fob in 2023, you can renew using the drop box 24/7, send a \$20 check via US Mail, or stop at the hall during clerk hours.

Building Inspector

This past spring, we were saddened by the passing of the Town's Building Inspector, Jim Webb. Jim performed his duties with professionalism and wit. He was well-liked and is missed.

We were able to contract with General Engineering Company (GEC) for the building inspection duties through December. In November, the Board accepted their proposal to perform the building inspection duties for the next three years. For building permit questions, contact GEC at 608-697-8007.

ATV Routes

Last August, the Town Board passed Ordinance 3-2022, an ordinance establishing all-terrain vehicle (ATV)/utility-terrain vehicle (UTV) routes and to regulate the operation of ATV/UTVs in the Town. The Town also coordinated with the County and established ATV/UTV routes on the County roads within the Town.

We ask residents to be aware of the regulations (see our website for details) and follow all safety rules.




Due to safety concerns, the Casberg Coulee bridge (at County Road V) was closed to traffic this past spring. A late spring storm caused undermining to the structure that had passed inspection a month previous. The Town Chair was able to submit a last-minute grant application for the Federal Bipartisan Infrastructure Law (BIL) for 100% replacement funding of the structure—an estimated cost of \$820,000+. That funding comes with several layers of government regulations (Federal, State DOT, DNR, etc.) and was projected to take 2-3 years. Meanwhile, the residents must travel a 3.7 mile detour. The Town Board has been diligently working towards accomplishing the construction at a very accelerated rate with a projected completion by November 2024.

Safety—MH Roundabout

On August 11, 2023, the roundabout construction occurring at the intersection of Briggs Road and McHugh Road was officially opened. Previously, the intersection at the entrance to the high school often saw traffic flow issues and caused safety concerns after multiple car accidents.

The construction was a collaborative effort between the Town of Holland, Village of Holmen, La Crosse County

The Stormwater Utility Commission has been studying and implementing practices to mitigate multiple flooding events by updating and maintaining infrastructures. To assist in paying for the work, the special charge on tax bills for Equivalent Runoff Unit (ERU) will remain the same this year as last year.

Next spring, the Town will be seeking bids for a much needed update to the Gaynor Rolling Hills Subdivision drainage ditches. Also in the works next summer is a clean-out of culverts and ditches in a majority of the Country Estates subdivision.

Bike and Pedestrian Paths

In 2022, the Town Board formed a citizen committee and hired a consultant to study the bicycle and pedestrian needs in the Town. That comprehensive study is available on our web page. The mission:

"The Town of Holland will work with La Crosse County and neighboring jurisdictions to provide a safe, efficient, and economically sound transportation system that meets the needs of all its residents, businesses and visitors."

As a result, the Town has formed a strategy which involves seeking grant money to assist with constructing bike/pedestrian paths. This past spring, the Town was awarded a grant to pave the current bike trail from Drugan's to Bluffview, with construction to occur in 2024. This will enhance the overall use of the trail and allow for handicap accessibility. The trail provides residents/students a safe route for biking and walking to Prairie View Elementary School as well as access to places of employment, parks and scenic rural areas.

In October, the Town applied for a grant to construct a bike/pedestrian path along the north side of County Road MH from Briggs Road to County Road XX. This path would provide residents a safe route to Holmen High School, parks, other schools and

Holmen businesses. If awarded, construction could begin as early as 2025.



Little Free Sled Library

Thanks to a donation from the Holmen Area Foundation, the Town Hall park sports a "sled library." Little Free Sled Libraries were created so that if your sled is broken or is lost, you can use one at no cost.

For winter fun, the Town has two sledding hills:

- (1) Town Hall Park—use gravel parking lot to the west of the Town Hall and the hill is to the southwest (facing County Road XX).
- (2) Hammes Park—use the parking lot south of the park equipment (turn onto Vermeer Street and left into the parking lot).

Your Tax Dollars at Work

Quite often the Town gets questions about where taxes go, why the Town collects so much in taxes, why there are fees for some services, why the Town can't set aside money for future expenses, and why the Town can't just raise taxes if a new large expense comes up. I'll try to clarify the questions using a real world example from a Town of Holland parcel.

Looking back as far as tax records are online (2007), the example property had a total assessed value of \$327,400. The total tax bill for that property that was due January 31, 2008 was \$6,093.00 collected by the Town. However, the Town has the responsibility to distribute the total taxes to each jurisdiction that levies the taxes. The Town only kept \$531.04 of that total tax bill. All the rest went to Holmen Schools, La Crosse County, and Western Technical College (WTC). So, all of the services provided by the Town in 2008 needed to be paid by the \$531.04 collected.

Moving forward to **2021** the example property had a total assessed value of \$465,500. The total tax bill for that property that was due January 31, 2022 was \$5,783.41 collected by the Town. The Town continues to have the responsibility to distribute the total taxes to each jurisdiction that levies the taxes. The Town only kept \$566.50 of that total tax bill. All the rest went to Holmen Schools, La Crosse County, and WTC. Again, all of the services provided by the Town in **2022** needed to be paid by the **\$566.50** collected.

If you look at your own income from any source, it has most likely increased between 2007 and 2022. The tax the Town received from this property did not increase at all in those 15

years. The slight increase seen was due to an increase in refuse fees and implementation of a stormwater fee. Otherwise, taxes remained flat and continue to remain flat even though the property value increased by 42%.

Simply put, there is no "extra" in the budget to set aside for future expenses. It is impossible to do so when income from taxes continues to be the same as it was 15 years ago. As expenses increase, the Town is forced to add fees to offset the increased costs for some services which may or may not be used by all Town residents. In the case of larger capital expenses like a plow truck or tractor, the Town can take out a loan to cover those expenses and add those costs to the tax bill as a levy adjustment. The Town Board tries to remain fiscally responsible and generate the most services for the taxes the Town receives.

In 2010 state legislators took away the ability for any municipality to raise taxes to cover expenses without getting voter approval. The consequence of that action was to force the Town to add fees for some services as expenses have increased.

In return for \$566 of taxes, the example property owner received annual services such as trash removal, plowing, parks and park maintenance, road repair and maintenance, fire and EMS protection, ditch mowing, stormwater repairs, brush chipping, employee salaries, Town equipment maintenance, and Town Hall maintenance. That seems like a great value for the money paid.

You can look at your own property taxes online and see what the numbers are for your situation. Hopefully, you, too, can feel that you do get value from the Town for the amount of taxes paid to the Town.

Holmen Area Fire Department


As a result of approval of the referendum last November, the Fire Department achieved full staffing by mid-2023 which meant 4 firefighters on duty 24/7. This has provided faster and more consistent response times. Also, a new Fire Chief, Ryan Ostreng, was hired and is proceeding with modernizing the department.

Late summer of 2023 also saw the arrival of a new fire engine which has greater water capacity in addition to the ability to respond to EMS calls.

The Town of Holland has appointed three residents to the newly established Fire Commission which will be tasked primarily with dealing with personnel.

Important Information!

Emergency notices. It is an unfortunate phenomenon, but we seem to get 100-year storms every year! While the Town cannot prevent these disasters, we will work hard to address them as quickly as possible. In cases of localized flooding or other weather events, residents can check the Town web site at www.townofhollandwi.gov or Facebook (TownofHollandWI) for road closures, storm clean-up actions, and other information.

<u>Well water testing.</u> Even if your drinking water looks, tastes, or smells good, it may still contain harmful bacteria and the only way to know is by testing. Pick up water testing bottles in the clerk's office or at the County Health Dept, 300 4th Street No, La Crosse, 608-785-9872 from 8 am-4:30 pm.

Speeding is one of the biggest complaints in the Town! Please keep in mind when you are traveling that the speed limits are set to protect the residents as well as the driver. *Please* be aware and **SLOW DOWN!**

Road right-of-way. Due to necessary maintenance of Town roads, decorative mail posts, flower boxes, or other items placed on the road right-of-way may be damaged. The Town is not liable for damages done to these items, nor to the grass edge along the road which may occasionally get peeled back by the snow plow blades. The right-of-way on most roads is 66 feet wide (33 feet from the centerline).

<u>Drainage ditches</u> cannot be filled in with dirt and/or sod. <u>Sprinkler heads should NOT be within the right-of-way</u>. The Town is not responsible for damaged sprinkler heads due to snow plowing or other road work. Downspouts should be placed to allow for infiltration throughout the yard (not placed directly in ditches).

Parking on cul-de-sacs and on Town roads is prohibited.

<u>Mailboxes</u> cannot be constructed with *concrete, brick or any other hazardous materials* that will not "break away" if hit by a vehicle. On the other hand, the Town will not be responsible for mailboxes that are so old/weak that they break due to snow pressure.

<u>Other obstacles.</u> No other obstacle should be constructed within the right-ofway, including brick pillars, large landscape rocks, or anything sticking up along the road edge.

No open burning. Burning leaves, refuse, or brush in yards or burn barrel(s) is illegal in the Town. Of course, grilling or cooking outdoors, campfires, fire rings/pits (with a 3-foot size limit) and outdoor wood stoves are allowed. Contact the Holmen Fire Department for allowable exceptions: 608-526-9363.

<u>Fire numbers.</u> It is Town code that each house display a double-sided green fire number. If your fire number is missing or has been damaged, contact the Town Clerk immediately. If a fire number is not present, you are in violation of Town code, which could result in a fine.

<u>Sand/salt.</u> The Town is not legally able to sell the winter sand/salt mixture nor are citizens allowed to take it. The materials need to be used for Town business and a driveway is not a Town road, and, therefore, not a Town use.

<u>Garbage/Recycling Carts.</u> Carts should not be put out before 5 pm the day before pick up and should be retrieved from the Town right-of-way as close as possible to 5 pm the day of pick up. Keep the containers at least 3 feet apart and 3 feet from any other obstruction.

Noise. Ordinance #6-2007 establishes a quiet time between 9 pm and 7 am.

Winter Information

The Town of Holland endeavors to maintain safe driving surfaces for vehicles properly equipped for winter driving conditions. This does not mean bare, dry pavement should be expected after each snowfall or ice storm event. Furthermore, this does not mean that the roads will be completely free of ice and snow during the season. Motorists are expected to modify their driving practices in accordance with the road conditions. In an effort to adhere to stormwater regulations, the Town will use discretion when applying sand/salt while keeping the roads in passable condition. Keep in mind that we generally do not plow if we have received less than 2 inches of snow.

Items installed or kept on any Town right-of-way (generally the area 33' from the centerline of the road) may be damaged by snowplows. Subsequently, any item other than a mailbox will not be replaced or repaired by the Town if struck by a plow. This includes underground sprinklers. Homeowners may also be liable for damage to Town equipment that results from striking objects in the right-of-way.

Please remember to give the plow vehicles plenty of room. They may not be able to see you!

Road Maintenance

Each year the Town budgets for maintenance on the 46+ miles of town roads. The Town contracts for the roads to be cleaned, crack filled and then seal coated on a 7-year cycle. This is not a fast process and does require driving a little more cautiously for about 6 weeks. Once the roads are cured, the contractor will sweep up the extra chips. While this may be inconvenient for a few weeks, it goes a long way to preserve the roads, rather than waiting for roads to fail. At that point, the road would have to be torn out and replaced. That process would take a few months and is also much more expensive. So, a little maintenance now will avoid major expense and inconvenience later.

Winter Safety

<u>Safe play areas</u>: For safety's sake, do not allow children to build and/or play in the snow banks at road's edge! Our plow drivers have a lot to watch when plowing and may not see children hiding in the snow bank!

<u>Do not plow or blow snow across roads!</u> Keep in mind that it is unlawful for any person, firm, or other agency, to throw, plow or otherwise discharge snow and/or ice from private property onto any roadway. State Statute 346.94(5)

All about Dogs!

Dog license renewals are due January 1st.

There is a misconception that dog licenses are due at the end of March. NOT true!

The license period starts January 1st and ends December 31st. So, in fact, licenses are due by <u>January 1st each year</u>.

The misconception occurs because there is a grace period to avoid a late fee until March 31st.

Dog Licenses

All puppies must be licensed within 5 months of birth. Renewal is due by January 1 with a grace period no later than March 31. (**Limit of 2 dogs per household.**)

We have a computer printout on dogs previously licensed in the Town of Holland. If the rabies vaccination is current, just send the correct fee. If the rabies shot expired since you purchased last year's tag, we will need to see proof of the current rabies vaccination.

It is the dog owner's responsibility to provide the rabies information (not the vet clinic).

Dog licenses can be purchased from the treasurer, Marla Wagner. This can be done via mail, Town Hall drop box, or during clerk hours at the Town Hall.

If by mail or drop box, please include a self-addressed stamped envelope so we can send you the tag.

Any rabies information will be returned as well.

For new dogs, you need to furnish proof of rabies vaccination, dog's name, breed, color, age/birthdate, and sex (indicate whether it is neutered or spayed). If the dog has been neutered or spayed, we will need written documentation.

For new residents or newly acquired adult dogs, all tags are to be purchased from the Town treasurer within <u>30 days</u> or the late fee will apply. A new puppy must be licensed within <u>5 months</u> of birth or the late fee will apply.

All nuisance dog calls are handled by the Coulee Region Humane Society (608-781-4014).

Leash Law

The Town of Holland does have a leash law. Unfortunately, we often receive complaints regarding dogs running in the neighborhood. And, while you may think your dog is wellbehaved, those walking/jogging or biking might not feel safe with dogs running at them. Section 3.01 of the Dog Control Ordinance #5-2007 has several sections that apply to the care of dogs:

- A. All dogs shall be cared for, maintained, and handled in a sanitary manner and in such a way as to prevent noises, barking, fighting or howling, or other disturbances of the peace and guiet of the neighborhood.
- B. Dogs shall not be permitted to run at large, with the exception of dogs confined and controlled within an electric dog fence.

Penalties may be assessed if a dog is running loose or disturbing the peace. Penalties for violations are established by La Crosse County Code and enforced by the La Crosse County Animal Control officers. If you have any questions on the penalties or violations, please call the La Crosse County Health Department at 608-785-9872.

For quick reference, a postcard recycler calendar is included in this mailing.

- ► Carts <u>may not</u> be placed within the right-of-way (33 feet from the center line) other than from 5 pm the day before service to 8 pm the day of service
- ► Place carts <u>2 feet from road edge</u> and at least <u>3 feet away from obstacles including but not limited to: other carts, recycling bins, mailboxes, power poles, etc.</u>
- ► Remove the carts from the right-of-way by the end of the collection day. If a vehicle or plow hits a cart, the homeowner must pay to replace it!!!
